Copenhagen Airport is the world's leading gate-way to and from Northern Europe.

No airport in the region is better located, serves more destinations, welcomes more passengers or provides such a well-supported infrastructure.

Direct flights to more than 150 destinations

With non-stop flights to 156 international destinations – including 36 intercontinental – the city is easy to access from all continents. All major European cities are within a one- or two-hour flight.

Getting Around

Thanks to its compact scale and extensive pavements, street crossings and pedestrian zones, Copenhagen is easy to explore by foot and is safe to walk around in day and night.

Copenhagen offers a well-functioning infrastructure with 400 kilometres of bicycle lanes and an extensive public transportation system that connects the various areas of the city centre as well as the suburbs.

Taxis are easy to hail on the street and most accept all major credit cards. All taxis are clearly licensed and operate at fixed mileage rates.

If you prefer to experience the city the Copenhagen way, it is easy to get a hold of a bike. Most bike shops and hotels offer bikes for rent, some hotels even lend bikes to their guests for free.



- Exhibit space is allocated on a first-come, first-served basis, with priority given to the sponsorship packages.
 - Technical manual containing all details for exhibition set-up will be available in January 2022.
 - All company representatives must check in at the registration desk and wear name badge at all times.
 - Payment terms: Full amount is payable within 14 days after signing this agreement.
 - Cancellation policy: Following receipt of the order confirmation, the order is binding and the company is committed to pay as per the above specified payment terms.
Cancellations up till 20 December 2021 will incur a cancellation fee of 15% of the total commitment, remainder of the paid fees will be refunded.
 - Force majeure: The performance of the specified Agreement by NCDV 2022 is subject to the following events that are beyond the reasonable control of NCDV 2022 including but not limited to:
 - War, included armed conflict
 - Strikes or labour disputes at the event venue
 - Government regulations
 - Disaster, fire
 - Cancellations up till 31 January 2022 will incur a cancellation fee of 50% of the total commitment, remainder of the paid fees will be refunded.
Cancellations from 01 February 2022 are non-refundable and require full payment of the amount stated in the order confirmation. The above applies even if the exhibitor withdraws from the contract or does not participate in the event.
 - Infectious disease epidemics and pandemics
 - Terrorism or threats of terrorism
 - Curtailement of transportation facilities
 - Should any of above prevent the event to be held or making it inadvisable, illegal, impossible, or commercially impractical to hold NCDV 2022 or to fully perform the terms of the agreement, the agreement may be terminated without penalty and with performance fully excused for any or more of these reasons by written notice from the organizer to the Sponsors and Exhibitors.
- If, for reasons beyond the control of the conference organisers, the conference is cancelled, the sponsor and exhibition fee will be refunded after deduction of expenses incurred by the NCDV 2022 conference.
